Limited License:

Miscellaneous:

This agreement shall become effective on the date signed below and will remain in effect until all responsibilities set out are fulfilled. The parties acknowledge that they will use their best good faith efforts to negotiate and resolve subsequent issues that may arise from this Agreement as a result of unforeseen occurrences and that may alter the conditions of this Agreement.

Cancellation Policy:

This agreement is effective as of the date signed below and shall remain effective until the end of the contract or until terminated by either party. All requests for refunds must be in writing, received, and confirmed at least 30 days prior to the sponsor’s URL or logo going live for the first time. Contracts cancelled up to 30 days of the contract will be issued a refund based on a prorated basis. Once the sponsors URL or logo go live, there shall be no refunds. AZMPI may terminate this agreement at any time by notifying the sponsor in writing or by e-mail. Upon such termination,
